### RECOMMENDED ACTION AND JUSTIFICATION:

Set public hearing for January 8, 2008 at 11am to approve fee increases for marriage licenses and fictitious business name statements and increase and implement fees for other County Clerk services.

In order to fund the new marriage licenses software module it is recommended that all costs associated with the issuance of a marriage license be increased. Further, it is recommended that other fees associated with the County Clerk's office be increased. Some of these fees will be needed for a future update to the County Clerk's software modules for Fictitious Business Name Statements, and other filings currently supported by the CATS software.

The proposed changes are reflective of the increased costs and are in line with surrounding counties and take into account the increased costs of the department. The last change to the fee schedule was in 2003 when the Fish & Game fees were increased due to increases mandated by the State.

The Board has previously increased fees to cover costs.
