**RECOMMENDED ACTION AND JUSTIFICATION:**

Discussion and approval of the County's 2007 Legislative Platform. Staff is requesting the Board to discuss, revise, and adopt the 2007 County Legislative Platform. Its primary purpose is to provide a basis for quick response by the County Administrative Office and the County's legislative consultants as issues arise. The platform also identifies the County's legislative priorities to help guide this office and County departments in recommending legislative positions. While support of no specific legislation is included, the platform emphasizes that legislation enabling repairs to State Highway 140 are of primary concern to this Board.

The County's legislative consultant, Advocation, Inc., has requested that all legislative requests be forwarded to them prior to January 23, 2007.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

In previous years, the Board has adopted a legislative platform and forwarded to our legislative consultant in the hope of getting new legislation adopted that will benefit Mariposa County. The last legislative platform was adopted in 2004.

Do not adopt a 2007 Legislative Platform. Staff and County departments will need to seek Board direction on certain legislative positions as they arise.
