**RECOMMENDED ACTION AND JUSTIFICATION:**

Approve the events occurring in the Mariposa Arts Park, the Mariposa Creek Parkway, and 7<sup>th</sup> Street on May 4-5, 2007, as part of the annual Mariposa's Butterfly Festival as a county sponsored event for insurance purposes. The Mariposa Downtown Merchants have again organized a festival that entails several activities and demonstrations happening in the downtown area. The Mariposa Arts Park will be used for a martial arts demonstration and listening to live entertainment. The Mariposa Creek Parkway will be used for butterfly chalk art, and a street fair will take place on 7<sup>th</sup> Street. In addition musicians and the "Flooies" from the Pioneer Wagon Train will be walking along the downtown sidewalk area. This is the second year of this event and the organizers plan on making this an annual event.

There is no cost to the County in making this an annual county sponsored event. The County's insurance policy will be responsible should any claims arise from the activities occurring at the Mariposa Arts Park, Mariposa Creek Parkway, and on 7<sup>th</sup> Street.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board adopted Resolution 06-158 on April 25, 2006, approving Mariposa's Butterfly Festival as a county sponsored event for insurance purposes and the event occurred without incident.

**ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

Do not make the activities occurring in the Mariposa Arts Park, Mariposa Creek Parkway, and on 7<sup>th</sup> Street during Mariposa's Butterfly Festival as a county sponsored event. The Mariposa Downtown Merchants will need to pay for insurance to use county facilities and county maintained areas for this event.
