#### RECOMMENDED ACTION AND JUSTIFICATION:

Approve the annual Friends of the Red Cloud Library St. Paddy's dinner as a county sponsored event. The Friends of the Red Cloud Library annually hold a benefit dinner at the Greeley Hill Community Club with proceeds from the dinner going towards the building fund for the construction of the new Red Cloud Library facility. The dinner will be on March 17, 2007, and alcohol will be served. The Friends of the Red Cloud Library are going through the necessary procedures to obtain a license to serve alcohol at the event.

In making this an annual county sponsored event it will be added annually to the list of events for the County's liability policy. There is no additional cost to the County in making this a county sponsored event. If there is a liability claim as a result of this event, then the County's insurance will be responsible.

#### BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board adopted Resolution 06-66 last year making this a county sponsored event, but only for 2006.

#### ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not make this a county sponsored event. The Friends of the Red Cloud Library will need to purchase insurance either through the county (approximately \$170) or from another insurance carrier. These additional costs may lessen the amount of money available for the library construction fund.
