Adopt a Resolution amending the contribution under the Public Employees' Medical and Hospital Care Act (PEMHCA) for the Service Employees International Union (SEIU), Local 535. The attached Resolution accurately reflects the changes to the contribution for retirees and provides the required direction to the CalPERS Board of Administration

BACKGROUND AND HISTORY OF BOARD ACTIONS:

During negotiations with SEIU, the Board of Supervisors approved a \$100 increase to the health contribution for the employee +1 plan. The Board has previously revised the County's contribution for retirees pursuant to contractual obligations and Government Code section 22892, which states that the employer contribution for employees and retirees shall be an equal amount.

RESOLUTION NO. 06-564

RESOLUTION FIXING THE EMPLOYER'S CONTRIBUTION UNDER THE PUBLIC EMPLOYEE'S MEDICAL AND HOSPITAL CARE ACT (PEMHCA)

WHEREAS, Government Code Section 22892(a) provides that a local agency contracting under the Public Employees' Medical and Hospital Care Act (PEMHCA) shall fix the amount of the employer's contribution at an amount not less than the amount required under section 22892(b) of the Act, and

WHEREAS, Mariposa County (Agency Code 0453) is a local agency contracting under the Act;

NOW, THEREFORE, BE IT RESOLVED, that the employer's contribution for each employee or annuitant shall be the amount necessary to pay the full cost of his/her enrollment, including the enrollment of family members, in a health benefits plan up to a maximum of:


