RECOMMENDED ACTION AND JUSTIFICATION:

Approve the Mariposa County Solid Waste & Recycling facilities annual holiday closure schedule.

Normal operational hours for the landfill and compost facility are Thursday through Monday 8 a.m. to 4 p.m., closed on Tuesdays, Wednesdays and holidays for public use. We are recommending that the holiday closure schedule for the County Solid Waste and Recycling Facilities be the day of the actual holiday rather than County observed holidays. For instance, if July 4th falls on a Sunday it makes sense to close on Sunday rather than Monday to avoid confusion with the public. The general public is used to the landfill being closed on actual holidays as this was the practice of the previous landfill operator.

Staff recommends that the annual holiday schedule for the Solid Waste & Recycling Facilities be for closures on the following approved Legal County Holidays as follows: New Years Day, Third Monday in January known as "Martin Luther King's Day", Third Monday in February known as "President's Day", last Monday in May known as "Memorial Day", July 4th known as "Independence Day", first Monday in September known as "Labor Day", second Monday in October known as "Columbus Day", November 11th known as "Veterans Day", Thanksgiving Day, and December 25 known as "Christmas Day".
