

**Recommendation**

It is respectfully requested that your Board: (1) approve continuing a Behavioral Health contract for residential board and care services with Acacia Board & Care; and (2) authorize your Chairman to sign the contract.

**Background/Current Situation**

This County does not operate board and care facilities and therefore contracts for such services. These services are necessary for people who are unable to live independently.

**Financial**

This contract will continue to be paid within the Mental Health budget unit 0402. The cost is \$4,788 per year, per client. The remainder of the board and care costs is paid for through the client's income. There is no impact on the general fund.
