## RECOMMENDED ACTION AND JUSTIFICATION:

Authorize Chairman to sign Agreement between the Superior Court of California and the County of Mariposa to enter into an Agreement for juvenile dependency legal services.

This Agreement will ensure that juvenile dependency legal services are provided and the Court will pay the County for those services in the sum of \$31,000 per year together with a 2.5% annual cost of living increase.

## BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board gave County Counsel direction to prepare an Agreement to increase the Superior Court's annual contribution to the County related to costs of juvenile defense attorneys from \$20,000 per year to \$25,000 per year together with a 2.5% annual cost of living increase on November 12, 2002. Since that time the Court Executive Officer has determined that the amount should be \$20,000 annually with a 2.5% annual cost of living increase and the Auditor has agreed with his analysis.

The County and the Court have had an informal agreement wherein the Court paid the County the sum of \$20,000 per year to offset the County's costs of indigent attorney defense for juvenile cases.

Based on the new Public Defender Agreement commencing on July 1, 2006, and agreement of the Court the annual sum will be increased from \$20,000 to \$31,000 per year.
