**RECOMMENDED ACTION AND JUSTIFICATION:**

Approve Amendment No. 1 to the contract with Valley Oil Company, LLC dated September 9, 2001 (for providing aviation fuel to the Mariposa/Yosemite airport) to extend the contract term to June 30, 2006.

The Public Works Department went out to bid for aviation fuel for the airport in November 2004. The low bidder was Avfuel Corporation, and independent supplier of aviation fuels. We were proceeding to enter into a contract with Avfuel but found out that they could not provide some of the support services at the airport that other vendors could, such as assistance with fuel testing, fuel dispensing equipment, charge card terminals, etc. We felt that these services were an essential component of what the airport needed from a fuel vendor, and did not want to award the bid to Avfuel for this reason.

Enough time has elapsed that we feel the best approach now is to rewrite the bid specifications and go out to bid again. In the meantime, however, we need to extend the term of the contract with Valley Oil Company, LLC (now EPIC Aviation, LLC) to continue supplying the airport with aviation fuel.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board approved the contract with Valley Oil at the meeting of June 11, 2002, Res. No. 02-210.

**ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

Do not approve the amendment, which would leave us without a contract for aviation fuel until re-bidding is complete.
