RECOMMENDED ACTION AND JUSTIFICATION:

Resolution authorizing Public Works to enter into an Agreement with Kleinfelder, Inc. to conduct special inspection and testing services for the Compost Facility

Cost of for these services are included in the financing for the project and are required by provisions of the Building Code. These services relate to soil tests, high strength concrete, shop welding and bolting for the steel building.

An hourly rate proposal for such services is attached as Exhibit A of the Agreement. The cost for such services can be estimated but not quantified on a "not to exceed" basis. The estimated budget for the work is \$19,242. The budget estimate includes inspection services at the shop of the building manufacturer and for field welding. It is not likely these services will be required because the manufacturer has a certified shop and field welding is not likely to be conducted. If these services are not required, the budget estimate would be reduced to \$13,642. The cost for these services was contemplated in the financing for the project.
