RECOMMENDED ACTION AND JUSTIFICATION:

2/4) Waive First Reading and Introduce Ordinance 2/4) Waive Second Reading and Adopt Ordinance Rescinding Section 10.08.063 of Chapter 10.08 of the County Code entitled "Parking Regulations at the Mariposa Roadside Rest Area".

Adopt Ordinance rescinding Section 10.08.063 of Chapter 10.80 of the County Code entitled "Parking Regulations at the Mariposa Roadside Rest Area". Section 10.08.063 restricts parking within the Mariposa Rest Area located westerly of the corner of Jessie Street and Coakley Circle within the township of Mariposa to four (4) hours.

At the time Section 10.08.065 was adopted by the Board of Supervisors the Rest Area was not being utilized as a Yosemite Area Regional Transportation System (YARTS) bus stop wherein employees and visitors traveling to Yosemite National Park can park their vehicles and travel by bus.

As a result of the YARTS ridership a four (4) hour parking restriction would not be in the public's best interest.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Ordinance No. 859 was adopted by the Board of Supervisors in 1993 restricting parking at the Mariposa Rest Area to four (4) hours.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If Section 10.08.063 is not rescinded the four hour parking restriction will continue to be enforced; therefore prohibiting employees and visitors to Yosemite National Park from utilizing YARTS.

MARIPOSA COUNTY ORDINANCE NO. 1057

AN ORDINANCE RESCINDING SECTION 10.08.063 OF THE MARIPOSA COUNTY CODE ENTITLED "PARKING REGULATIONS AT THE MARIPOSA ROADSIDE REST AREA"

WHEREAS, the Board of Supervisors desire to rescind Section 10.08.063 in its entirety, and

WHEREAS, at the time that Section 10.08.063 was adopted by the Board of Supervisors the rest area was not being utilized as a Yosemite Area Regional Transportation Systems (YARTS) bus stop wherein employees and visitors traveling to Yosemite National Park can park their vehicles and travel by bus, and

WHEREAS, as a result of the YARTS ridership a four (4) hour parking restriction would not be in the public's best interest,

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:


SECTION I: Section 10.08.063 of Chapter 10.08 of the Mariposa County Code is hereby rescinded.

10.08.063 Parking regulations at the Mariposa roadside rest area. (Rescind)

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code §25123.


