RECOMMENDED ACTION AND JUSTIFICATION:

Public Works recommends that the Board of Supervisors adopt this resolution:

1. Approving the map of MARI PLAZA, Major Subdivision No. 3/08/95;
2. Accepting on behalf of the public, the dedications of public utility easements as shown on said map;
3. Accepting for public use, but not for maintenance, the dedications of public road easements, and;
4. Authorizing the Clerk of the Board to sign the map.

State Law requires that the Board approve the map if it conforms to the approved tentative map. The map of MARI PLAZA conforms to the tentative map approved by the Mariposa County Planning Commission on June 2, 1995.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

State law and County Code require approval of final maps by the Board of Supervisors. The Mariposa County Road Improvement and Circulation Policy spells out the criteria for acceptance or rejection of dedications; the recommendations contained herein conform to those policies.

1. The Board could reject the dedications of public utility easements; if so, no public utility easements would be created for existing and future utilities.



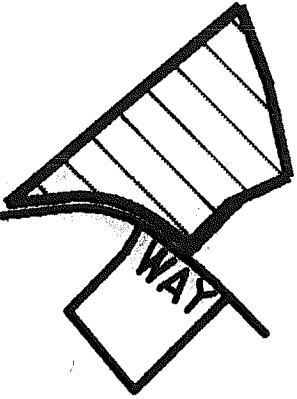
