RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No ^{XX})

That the Board of Supervisors adopt this resolution designating the appropriation limits to be computed for each jurisdiction as follows:

For the Mariposa Lighting District - by the percentage change in the local assessment roll due to nonresidential new construction in conjunction with the annual percentage change in population of Mariposa County.

For all other jurisdictions - by the percentage change in California per capita personal income in conjunction with the annual percentage change in population of Mariposa County.

Mariposa Lighting District will exceed its limit if calculated under the personal income method which would require a return of excess tax proceeds to that district.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

In the past, we have calculated the appropriation limit by the change in California per capita personal income. We were able to obtain data for the 1994-95 fiscal year to calculate the limit for the Mariposa Lighting District by the percentage change in the local assessment roll due to nonresidential new construction.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Mariposa Lighting District will exceed its appropriation limit under the change in personal income calculation. Not adopting the recommended action will result in a return of taxes to that district.
