RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes\_\_ No X)

Resolution authorizing appropriation of \$1,500 from Yosemite West Utility Capital to purchase a dissolved oxygen (D.O.) meter for use at the Yosemite West wastewater treatment pond.

Purchase of this fixed asset will minimize additional trips by maintenance personnel to and from the Yosemite West district. Currently, there are only two D.O. meters and four locations that require frequent use of the meters. If the purchase is approved, one meter can be used to cover the north side rounds, one for use at Mariposa Pines and the new one can be kept at Yosemite West. This would eliminate costly travel time to use the meters.

The current balance of the Yosemite West Utility Capital Fund, prior to the purchase of this equipment, is \$20,274.55.
