Request to Schedule Evening Meeting for 6 pm, September 24, 1996 for presentation on alternatives for Highway 140 sidewalks in the Town of Mariposa and solicit public and Board input. This meeting would be held concurrently with the Mariposa Town Transportation and Parking Advisory Committee.

An evening meeting is requested to permit business owners and employees an opportunity to view the presentation and offer input. The more design questions that can be answered, the faster the final design can progress. Public Works will advertise this meeting extensively, including direct notices to the affected property owners and businesses.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The LTC approved an application for \$ 526,657 of Proposition 116 funds to construct sidewalks in the towns of Mariposa and Greeley Hill on May 4, 1993. The LTC executed the fund transfer agreement for design work on December 19, 1995. The design work is scheduled to be completed this fall with construction next spring. The committee has been meeting very often on this project, providing valuable design recommendationas and meeting directly with business owners.

### LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

An afternoon or morning meeting would not allow the business owners the opportunity to view the presentation, unless they can find someone to watch their business while they attend. The Board could select another evening date if desired.
