Subject: Justification for Public Works' Take-Home Vehicles

This memo primarily addresses my recommendation that the Road Division foremen and Fleet foreman be allowed to take their County vehicles home on a year-round basis. The Board has concurred with the current arrangement on take-home vehicles and those justifiable circumstances; i.e., winter response time for the Road and Fleet Divisions' foremen and year-round response by the Facilities Division personnel relative to water and sewer failures. I will not further address those issues.

As you know, a good deal of the Road foremen call-outs occur during the "summer" season (from April 1 through November 1). Well over half of those call-outs are in response to situations that require rapid attention due to public safety concerns. Examples include downed trees, wash-outs, slides and traffic control for wildland fires. Admittedly, some are for non-urgent call-outs such as to remove dead deer. A good deal of the call-outs for the Fleet foreman are also related to emergency response, usually for repairs to either fire or police vehicles. As the minimum call-out time in these situations is three hours, there is rarely any direct cost savings as most issues can be dealt with in less than three hours. In my opinion, the overriding concern is the potential cost to the public that could be incurred without a rapid response. It is difficult to quantify and put a dollar figure on those public safety issues. However, the prevention of one bad vehicle accident or clearing of a road to avoid an ambulance delay would seem to justify the relatively small cost.

The additional issue that I feel very strongly about that also cannot be quantified is worker morale. As a manager of a large staff, this is a very important consideration. I know that morale has suffered as a result of eliminating or reducing take-home vehicles for foremen-level positions. As you know, there is not a great salary difference between the positions of the top-level maintenance worker and foreman. In the past, the availability of a County take-home vehicle has provided an incentive for the maintenance worker to excel, in hopes of eventually reaching the foreman position. I feel this is an important consideration.

In summary, it is important that the Board consider these intangible criteria. To me, they are important enough that I would be more than willing to absorb the additional cost within our existing Road and Fleet budgets without requesting additional funding from the Board.
