RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes____ No_x_) Adopt the attached Resolution Electing to Continue Participation in the Trial Court Program for the Fiscal Year July 1, 1995 through June 30, 1996

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Trial Court Funding Program requires an annual opt-in resolution each fiscal year. The Board has opted into the Trial Court Funding Program for fiscal years 1991/92, 92/93 and 93/94 and 94/95 (Resolutions Nos. 90-490, 92-89, 93-94 and 94-41). While there are many changes possible between now and adoption of the state budget, the just released Governors Budget states a goal to increase state funding of courts from approximately 34% to 70% in 1995/96. In order to qualify for fiscal year 1995/96 funding established under the Brown-Presley Trial Court Funding Act, the County must agree by resolution to be bound by the provisions of the program. Pursuant to Government Code Sections 77300 and 77301 as amended by AB 1084, Chapter 389 of 1994, the opting resolution must be postmarked no later than March 1, 1995.

Government Code Section 77301 as amended no longer requires judicial signoff which was required in past resolutions, however, the Superior Court Judge and Municipal Court Judge recommend continuing in the Trial Court Funding Program.

- 1. Approve the resolution and the Trial Court Funding program will continue.
- 2. Do not approve the resolution. The County will not qualify for the appropriated State funding for trial courts.

MARIPOSA COUNTY RESOLUTION NO. 95- 34

RESOLUTION ELECTING TO BECOME SUBJECT TO THE PROVISIONS OF THE TRIAL COURT PROGRAM

FOR THE FISCAL YEAR JULY 1, 1995 THROUGH JUNE 30, 1996

WHEREAS, the passage of SB 612, Chapter 945 Statutes of 1988 which repealed and added Chapter 13 commencing with Section 77000 to Title 8 of the Government Code, known as the Brown-Presley Trial Court Funding Act, and with the passage of AB 1197, Chapter 1944 Statutes of 1988, allows an option county to receive from the State quarterly block grants based on sums specified pursuant to Government Code Section 77200; and

WHEREAS, the Brown-Presley Trial Court Funding Act establishes a program of State funding of trial courts as specified in Government Code Section 77300 provided that sufficient monies have been appropriated in the State Budget Act for the fiscal year to adequately fund the program; and

WHEREAS, the decision by the County of Mariposa to opt into the program pursuant to Government Code Section 77300 shall result in the opting county agreeing to perform all duties and provide services required by the Brown-Presley Trial Court Funding Act and all other provisions of law;

NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Board of Supervisors of Mariposa County hereby elects, pursuant to Government Code Section 77301 to opt into the Trial Court Funding Program for the 1995-96 fiscal year beginning July 1, 1995, and agrees to be bound by the provisions of this program in consideration for State funding of trial courts; and certifies that a majority of the Board of Supervisors requests State funding;

BE IT FURTHER RESOLVED, that the Clerk of the Board is directed to notify the State Controller forthwith of this election.

This Resolution shall take effect upon its adoption.
