RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes___ NoXX_)
AUTHORIZE THE SHERIFF TO APPLY FOR A "COPS MORE" FEDERAL LAW ENFORCEMENT GRANT. THIS PROGRAM IF APPROVED BY THE FEDERAL GOVERNMENT WOULD PROVIDE FOR THE PURCHASE OF EQUIPMENT FOR IN THE FIELD COMPUTING, VIDEO ARRAIGNMENT AND ONE FULLY EQUIPPED 4X4 PATROL VEHICLE. BY IMPLEMENTING THIS PROGRAM IT WILL RESULT IN THE EQUIVALENT OF 5.8 FULL TIME OFFICERS BY THE TIME SAVINGS THAT IT WILL CREATE. THIS WOULD BE FACILITATED BY THE REDEPLOYMENT OF THOSE OFFICERS TO A COMMUNITY POLICING EFFORT. THE COST OF THE PROGRAM IS \$129,116.00. OF THAT \$ 32,279.00 WOULD REPRESENT THE COUNTY'S REQUIRED MATCH FUNDING.
