SUBJECT: DEPARTMENT OF ENERGY WEATHERIZATION PROGRAM

In the past, Mariposa County has implemented two weatherization programs: Low Income Home Energy Assistance Program and the Department of Energy Program. Both are similar in eligibility requirements and energy conservation measures and techniques.

Over the past three years, changes in Program regulations have substantially increased the number of "working" families eligible for the weatherization programs. In Mariposa County, over 70% of families receiving services are either working, elderly, or disabled.

According to the 1990 Census, an estimated 1,500 households are eligible. To date, approximately 860 housing units have been weatherized with less than 25 units having been "re-weatherized".

A large percentage of the subject DOE Weatherization funds will be used to support the Community Development Block Grant housing rehabilitation program at the Watt Road American Indian allotment.

Pursuant to previous Board direction, County discretionary funds will not support the Program whatsoever and the County is under no obligation to continue the Program if Federal grant funds are discontinued.

It must be noted that administrative funds from the weatherization programs support HCDA in general and the Director and Contracts Coordinator positions in particular.
