A RESOLUTION RECOGNIZING DIANE DEAN FOR HER
EFFORTS IN THE HEALTH FIELD AND CONTRIBUTIONS TO THE
COMMUNITIES OF YOSEMITE, EL PORTAL AND SURROUNDING VICINITIES

WHEREAS, DIANE DEAN, Registered Nurse, Nurse Practitioner, through her medical work at the Yosemite Medical Clinic has served the citizens of Yosemite National Park, El Portal, and adjacent communities over the past six years, and

WHEREAS, DIANE has met the preventative medical needs of many, with her active involvement in the areas of childhood screening programs; special immunization clinics; health advice to daycare providers; the county tobacco cessation program, including client interaction; logistical support for tobacco educational events in the park; participation on the Mariposa County Tobacco Coalition; in the execution of health fairs; and most recently, by providing comprehensive perinatal services to pregnant women; and

WHEREAS, the children in Yosemite National Park, El Portal, and surrounding vicinities have received the kind and loving attention of DIANE, when they were ill, when they were well, and when they needed medical screening services; and
