A RESOLUTION RECOGNIZING FRANK DEAN FOR HIS
SERVICE TO YOSEMITE AND THE COMMUNITY OF MARIPOSA

WHEREAS, FRANK J. DEAN, obtained a Masters of Public Administration through the University of San Francisco and a Business Administration Degree through San Francisco State University, providing **FRANK** with a strong educational foundation for a career with the National Park Service; and


WHEREAS, FRANK's career with the National Park Service began in 1977, and is still progressing today with merited promotional opportunities. During **FRANK's** employment with the National Park Service he has served in the capacities of Park Ranger with the Sequoia and Kings Canyon National Park, Park Ranger (Resource Management) with Golden Gate National Recreation Area, Park Ranger with Golden Gate National Recreation Area at Marin Headlands, Park Ranger with Yosemite National Park at Yosemite Valley, Assistant to the Superintendent with Yosemite National Park and his recent appointment to the position of Assistant Superintendent with Point Reyes National Seashore; and

WHEREAS, due to FRANK's recent appointment to Point Reyes National Seashore, **FRANK**, along with his wife **DIANE** and son **PARKER**, will be relocating and leaving Yosemite, California. **FRANK's** experience, communication skills, and personal attributes will be greatly missed here, but will certainly be valued by the community of Point Reyes; and

WHEREAS, while fulfilling his duties with Yosemite National Park Service, FRANK made numerous contributions to the communities of El Portal and Yosemite, as well as the County of Mariposa. A few of **FRANK's** accomplishments and contributions are as follows: Instrumental in the establishment of the Yosemite Regional Transportation Committee; actively sought funding for non-profit, day-care centers in El Portal and Yosemite; assisted in obtaining funds through the Intermodal Surface Transportation Efficiency Act for needed projects, such as the El Portal pool grounds; worked with multiple agencies on the Merced River Trail; was dedicated to the re-building efforts at Foresta in Yosemite; assisted with negotiations for fire, ambulance, and search and rescue services; collaborated funding issues with the Federal Government, Mariposa County and Mariposa County Unified School District and helped to establish clear and open communications between such public entities; credited with making Yosemite a nature-friendly national park; known as a role-model for park rangers; and coordinated plans aimed at the preservation of the national treasure of Yosemite National Park by reducing commercial influences and overcrowding;

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Mariposa County, a political subdivision of the State of California, hereby recognizes **FRANK J. DEAN** for his service to Yosemite and the Community of Mariposa, and is warmly wished a long and prosperous future.






