A RESOLUTION RECOGNIZING
GEORGE W. GRIFFITH FOR HIS SERVICE TO THE
COUNTY OF MARIPOSA AND THE DISTRICT ATTORNEY'S OFFICE

WHEREAS, on February 2, 1987, GEORGE W. GRIFFITH moved to Mariposa, California, and began his career with the Mariposa County District Attorney's Office as an Assistant District Attorney. In September of 1988, GEORGE was appointed by the Mariposa County Board of Supervisors to the position of Acting District Attorney; and

WHEREAS, GEORGE continued serving in the capacity of Acting District Attorney until December of 1988, when he resumed his duties as Assistant District Attorney; and


WHEREAS, during the Primary Election of 1990, GEORGE was elected by the people of Mariposa County to the Office of District Attorney/Public Administrator; and


WHEREAS, as District Attorney/Public Administrator, GEORGE established the District Attorney's Office Child Abduction Unit, participated in the creation of a statewide Child Abduction Committee, received the highest conviction rate (98%) for driving under the influence violations in the State of California, served on the Small Counties Committee of the California District Attorney's Association, served as a member of the California State Bar Association and was past President of the Mariposa County Bar Association; and

WHEREAS, GEORGE was also active within the community and served as a member of the following: Mariposa Lions Club, Free and Accepted Masons (Mariposa) 32nd Degree Scottish Rite, Mariposa County Fish and Game Association and the Mariposa County Chamber of Commerce;


NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Mariposa County, a political subdivision of the State of California, hereby recognizes GEORGE W. GRIFFITH for his service to the County of Mariposa and the District Attorney's Office, and is wished a happy and successful future.


