Resolution to waive all future disposal tipping fees at the Mariposa Landfill for the Mariposa County chapter of the Salvation Army.

The Salvation Army provides very valuable services, including the recycling of old but usable goods and materials. Unfortunately, their recycling container has been used by some individuals to dispose of their unwanted rubbish. The disposal of the rubbish at the landfill has placed a real financial burden on the local chapter.

This waiver would result in a loss of income to the Solid Waste Enterprise Fund of approximately \$150 per year.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Similar action was approved by the Board for the Society for the Prevention of Cruelty to Animals on August 24, 1993 (Res. #93-458).

ACTION AND VOTE:

B) Resolution Waiving Landfill Disposal Tipping Fees for the Salvation Army
BOARD ACTION: (M)Balmain, (S)Reilly, to approve request, was withdrawn following discussion. Supervisor Parker requested that Public Works give consideration to establishing a disposal fee for the next fee hearing for those who dispose of one or two bags of refuse at a time. Discussion was held concerning the unlawful disposal of refuse. Mike Edwards advised of his contact with the Sheriff's Department and of request for the SCOPE program to include this matter in their patrol, and advised that signs have been ordered to assist in deterring this type of disposal. Discussion was held relative to other organizations that may be experiencing problems with refuse being disposed in their collection efforts, and whether the Solid Waste budget should be reimbursed for any fees that are waived. (M)Reilly, (S)Stewart, Res. 95-356 adopted approving request by Salvation Army for one year, with direction given for staff to review the whole issue as discussed/Ayes: Unanimous. Gordon Peterson/Salvation Army volunteer worker, commented on the matter.
