RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No X)

Recommend that Chairman of the Board of Supervisors Gary Parker sign a three year contract with California Department of Forestry for dispatch services and command and control function on behalf of Mariposa County. And Amendment Number One for 1995-1996. CDF handles all Mariposa County Fire Department dispatching and is the agency responsible for the command of people and equipment at a major incident in the County. By having CDF handle dispatch, County Fire is linked in a state wide communication system with other agencies. By utilizing CDF Chief Officers as people responsible for command and control at major incidences, the County can draw from the CDF resources for year around coverage. Under the current system the County pays for command and control November through May and CDF provides it at no cost during the fire season months, June through October. As part of the three year contract CDF delivers to the County Fire Chief an estimate of cost for the upcoming year.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Board has signed similar agreements in the past. CDF has provide services to Mariposa County for the last twenty-five years.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not sign agreement, County Fire would need to find another dispatch and command and control source.
