RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes___ No X)

Public Works recommends that the Board adopt bid and contract documents for the Lake Don Pedro County Sewer Rehabilitation, Public Works project number PW 91-05, authorize advertisement for sealed bids, set a bid opening date for Friday, September 22 at 10:00 a.m. and authorize the Public Works Director to execute a contract with the lowest responsible bidder.

Bid documents have been prepared by Nolte and Associates, Inc., of Manteca, CA.

This is a formal bid in accordance with the recently enacted Mariposa County Ordinance #886 and the Uniform Construction Cost Accounting Act, since the bid is expected to be greater than \$75,000.

This project will result in the replacement of approximately 1680 lineal feet of sanitary sewer line, 224 feet of laterals, and 12 manholes. This project is expected to significantly reduce the inflow/infiltration (I/I) component of flow entering the treatment plant.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On August 8, Public Works and Nolte and Associates presented a status report on the proposed sewer rehabilitation to the County Water Agency. The Water Agency concurred with the revised concept for rehabilitating the on site wastewater treatment facility. This concept also includes rehabilitation of the sewer collection system. The Water Agency approved expenditure of a portion of the previously committed funding (\$234,172) for the collection system repairs.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

No action will delay completion of this program. This type of work needs to be completed during the summer/fall construction season. It is desirable to reduce I/I before this next winter.

NOTICE Inviting Proposals or Bids

Sealed proposals or bids for the construction of the Lake Don Pedro Sewer Rehabilitation Project within Mariposa County, will be received at the office of the **Public Works Department, 4639 Ben Hur Road, Mariposa, California 95338**, until: **10:00 A.M., September 22, 1995** (no bids shall be accepted after this time), at which time they will be publicly opened and read, for performing work as follows:

Remove and replace 1,564 lineal feet of 6 inch sanitary sewer line, 8 house sewer laterals, 12 manholes, and install 140 lineal feet of 16 inch diameter casing

Bids shall be addressed to the Department of Public Works, and shall be endorsed **"Proposal for Lake Don Pedro Sewer Rehabilitation, PW# 91-05"**, on the face of the sealed envelope.

The work to be performed consists of furnishing all labor, equipment and materials, except as otherwise specified in the specifications, which are required to install/construct/replace sewer line and man holes. The work consists of the installation complete, as shown on the plans and specifications.

Contractors shall not bid portions of the project, but must bid the project as a whole.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the ground of race, color, or national origin in consideration for an award. A numeric goal for Disadvantaged Business Enterprise participation of ten percent (10%) has been established by the Department.

The percentage for DBE participation shall be measured as the dollar volume of work to be done, and/or materials or equipment to be supplied, by DBE subcontractors, divided by the total contract bid. DBE's must be currently registered with and certified by a state or federal agency, such as CalTrans, as a bonafied DBE. A copy of the current certification for each DBE shall be submitted with the bid.

BIDDERS shall be experienced and licensed in the installation of sanitary sewer lines. The BIDDER shall have good references and BIDDER shall have available equipment and materials to perform this scope of work. Each BIDDER shall submit with his bid a statement setting forth his experience, qualifications and business standing.

It is the responsibility of the BIDDER to read and understand the Specifications before submitting his BID. Any questions should be directed to Dave Tucker, Sr. Civil Engineer, or Clif Price, Facilities Maintenance Manager, Public Works Department, Mariposa County at (209) 966-5356.

This is a Public Works Project. In accordance with the provisions of Sections 1770-1774 of the Labor Code, the Contractor and any subcontractors shall conform to the general prevailing rate of wages as determined by the Director of Industrial Relations. Copies of the wage rate determinations, or any amendments thereto, issued by the Director of Industrial Relations may be reviewed at the office of the Contracting Agency. Contractors are encouraged to refer questions regarding current prevailing wage rates to the Division of Labor Statistics

and Research, Prevailing Wage Unit. P. O. Box 603, San Francisco, California, 94101, telephone number (415) 557-0561. The Department of Industrial Relations is responsible for determining the general prevailing rate of per diem wages for each classification of worker employed on a public works project of \$1000 or more. Contractor or subcontractor who intends to use a craft or classification not shown on the general prevailing wage determinations may be required to pay the wage rate of that craft or classification most closely related to it as shown in the general determinations effective at the time of call for bids.

No bid will be considered unless it is made on a blank form furnished by the County of Mariposa and is made in accordance with the provisions of the proposal requirements and conditions set forth in the contract documents.

The County reserves the right to reject any or all bids, and to waive any informality in the BIDS.
