Recommend Board direct staff with the respect to modification of By-Laws for the Mariposa County Emergency Medical Care Committee (EMCC) with respect to appointing alternates.

By Resolution 95-131 the Board of Supervisors adopted the By-Laws of the Mariposa County EMCC in their most recent revision last year. One member of the EMCC requested that an alternate be able to vote for him, in his absence, at the EMCC, thus guaranteeing representation for his agency (CDF). The current allowance for this in the By-Laws (which is a paragraph which has been present in the By-Laws of the EMCC for well over a decade) is found under Article III, Section 3 (copy enclosed). This allows each committee member to select an alternate without requiring appointment by the Board of Supervisors. The Board may wish to control this process through the appointment mechanism in which a change in By-Laws will be required.
