A RESOLUTION RECOGNIZING DANIEL J. "DAN" MARTINEZ  
RETIREMENT FROM THE CALIFORNIA YOUTH AUTHORITY

WHEREAS, Daniel J. "Dan" Martinez has been Community Volunteer Coordinator for 15 years, supervising the much needed community services which the Mt. Bullion Wards have rendered in Mariposa County.

NOW THEREFORE, BE IT RESOLVED, by the Mariposa County Board of Supervisors, a political subdivision of the State of California, that Daniel J. "Dan" Martinez be commended for the service he has rendered to the Wards of the California Youth Authority, Mt. Bullion Facility, and to the citizens of Mariposa County.
