A RESOLUTION AMENDING CONFLICT OF INTEREST CODE RESOLUTION
NO. 85-53 RELATIVE TO EXHIBIT "A" ONLY


WHEREAS, the Mariposa County Board of Supervisors on March 1985, passed and adopted the Uniform Conflict of Interest Code; and

WHEREAS, certain amendments have been made updating EXHIBIT "A" of the Uniform Code;


NOW, THEREFORE, BE IT RESOLVED by the Mariposa County Board of Supervisors, a political subdivision of the State of California, that EXHIBIT "A", attached hereto and incorporated herein by reference, shall constitute the appendix required by Section 18730 of the Uniform Code and may be amended annually or more often to reflect changes in County staff or organization.

E X H I B I T "A"
