RECOMMENDED ACTION: The impact of future funding cuts is a requirement that need to be included with the Local Plan. The 1990 estimated allocation for the CSBG grant is \$10,000.00. Using the CSBG grant for administrative purposes provides flexibility that other grants with minimum administrative funds will not allow. That flexibility allows for research and development of additional funding sources and program development. The most judicious use of the grant to reach DEO's goal and objectives of helping low-income people reach self sufficiency is for administration and coordination of available programs, as well as, to explore alternative funding sources.

HISTORY OF BOARD ACTIONS:
 In the past, the CSBG grant has been used for the administration of low-income programs. The grant has been reduced from \$11,704.00 to the present allocation of \$10,000.00.

CONSEQUENCES OF NEGATIVE ACTION:
 The necessity to fund the administrative portion of some of the programs from other sources. The development and/or research of additional available funding would be limited. Ongoing coordination of the programs currently available for the low income would change.

1. Do not submit a local plan to the Department of Economic Opportunity.
 2. Revise or change the grant objectives.
 3. Use the grant for other purposes.
