MARIPOSA COUNTY RESOLUTION NO. 89-397

**A RESOLUTION COMMENDING LIEUTENANT ROLLIN A. "DOC" WRIGHT  
ON HIS DEDICATED SERVICE TO THE CITIZENS OF MARIPOSA COUNTY**

**WHEREAS, LIEUTENANT ROLLIN A. "DOC" WRIGHT'S** career as a California Highway Patrolman began in July 1960 with assignments to metropolitan areas including San Jose and San Leandro; and whereas in August 1967, he became the first member of his Academy class to achieve the rank of Sergeant serving in Yuba-Sutter, Tracy, the California Highway Patrol Academy and Operational Planning Section; and

**WHEREAS, during his off duty time, LIEUTENANT ROLLIN A. "DOC" WRIGHT** attended California State University, Sacramento as an instructor and student earning a Bachelor of Arts Degree in Vocational Education, Police Science and Administration; and whereas he entered the Graduate Studies Program earning a Master of Arts Degree in both Criminal Justice and Social Science; and

**WHEREAS, In January 1974, LIEUTENANT ROLLIN A. "DOC" WRIGHT** was promoted to his present rank and assigned to the Office of the Commissioner and later transferred to the Los Banos Area; and whereas in April 1974 he became the first member of the Department to be assigned to a foreign country or territory by receiving a one-year special assignment to the Territorial Police of American Samoa; and

**WHEREAS, in May 1979, LIEUTENANT ROLLIN A. "DOC" WRIGHT** was assigned Area Commander of Mariposa and Eastern Madera Counties and upon his retirement had served longer in that capacity than any other Lieutenant/Commander; and whereas in addition to his administrative duties, he has been actively involved in both communities, participating in the Chamber of Commerce, John C. Fremont Hospital Foundation, Fish and Game Association, Mariposa Lions Club, Yosemite Rotary Club, BPO Eiks Oakhurst Lodge, Emergency Medical Care Committees and Alcohol Advisory Board;

**NOW, THEREFORE, BE IT RESOLVED** by the Mariposa County Board of Supervisors, a political subdivision of the State of California, that **LIEUTENANT ROLLIN A. "DOC" WRIGHT** be commended with heartfelt thanks of the County of Mariposa and her citizens for his unselfish and dedicated service; and

**BE IT FURTHER RESOLVED** that **LIEUTENANT ROLLIN A. "DOC" WRIGHT** be wished every success in his future plans and many happy years of retirement.
