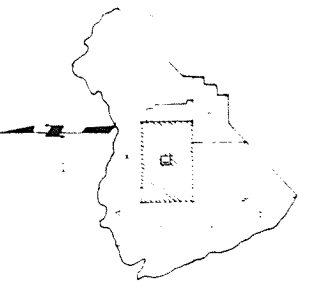

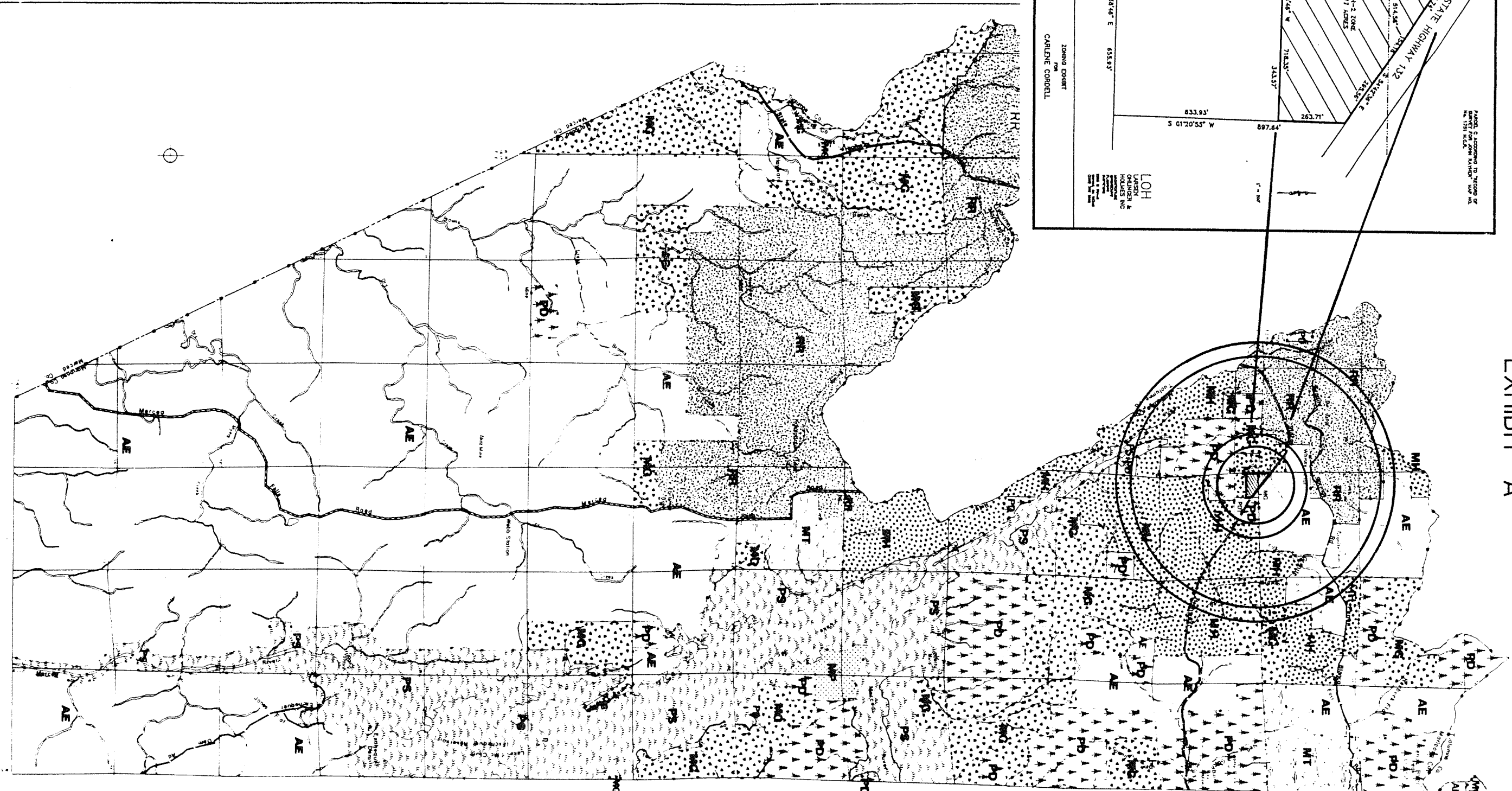
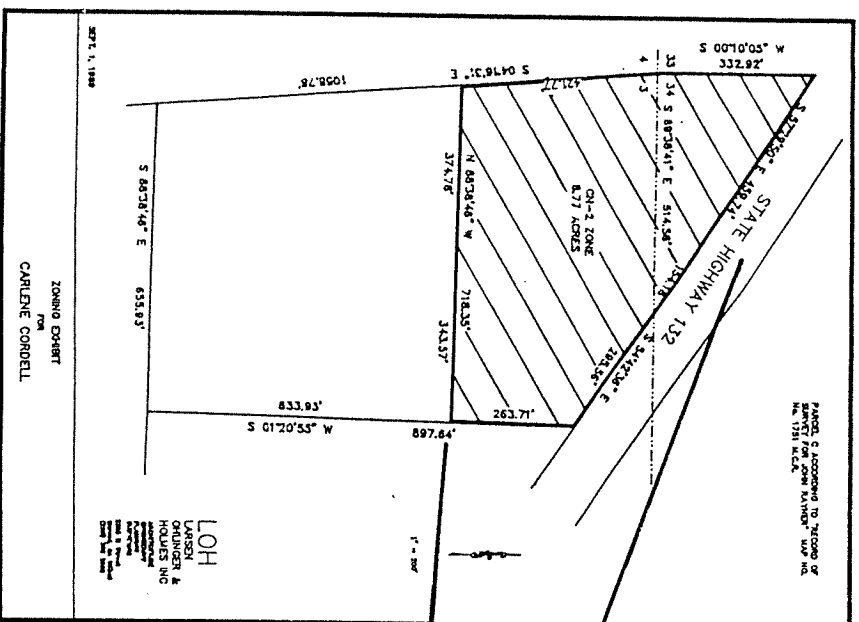
GENERAL PLAN /

BASE MAP**

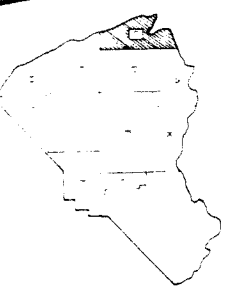

2 A RESOLUTION APPROVING MODIFICATIONS TO THE LAND USE ELEMENT OF
3 THE MARIPOSA COUNTY GENERAL PLAN

5 amendments to the General Plan Land Use Map and has initiated
6 text amendments to the Land Use Element of the General Plan; and

7 WHEREAS, environmental review has been conducted on the
8 amendments in accordance with the California Environmental

10 Policies and Procedures adopted pursuant thereto; and

11 WHEREAS, the Mariposa County Planning Commission and Board
12 of Supervisors have held duly noticed public hearings on the
13 amendments in accordance with State Law and County Code.
