MARIPOSA COUNTY RESOLUTION NO. 89-616

A RESOLUTION VACATING AND ABANDONING A PORTION
OF COUNTY ROAD 163

WHEREAS, the Mariposa County Board of Supervisors has passed and adopted Resolution No. 89-550, which stated its intention to abandon a portion of County Road 163; and

WHEREAS, the Board of Supervisors set a public hearing on this matter, and public notice of said hearing has been properly posted and published; and

WHEREAS, the necessary public hearing has been held pursuant to law; and

WHEREAS, the Board of Supervisors affirmatively finds that that portion of

Mariposa County Road No. 163, situated in Gov't. Lot 54, Section 3, T.3 S., R.16 E., M.D.B. & M., County of Mariposa, State of California; Beginning at a point on the existing County Road No. 163 which is 1950 feet northwesterly from the westerly right-of-way line of State Hwy. 49 as measured along said Road No. 163; thence along said Road No. 163, northwesterly through said Gov't. Lot 54, 0.24 miles more or less to the southwesterly line of said Gov't. Lot 54 being the end of the County maintained road,

is unnecessary for present or prospective public use within the meaning of Streets & Highways Code Section 954, and said portion has been impassable for vehicular traffic and no public money has been expended for maintenance for more than five years.

NOW, THEREFORE, IT IS RESOLVED that this Board hereby determines and orders as follows:

1. The County of Mariposa, by and through its Board of Supervisors, abandons that portion of County Road 163 as described in this resolution pursuant to Streets & Highways Code Section 954.

2. That portion of County Road 163 as described in this resolution revert to the owner of the property on which it lies free of public easement for street purposes and all other public purposes.

3. That a certified copy of this resolution be recorded in the office of the Mariposa County Recorder by the Clerk of the Board, and upon such recordation, the abandonment shall be complete.
