RE: Administrative Match Agreement with Area 12 Agency on Aging

RECOMMENDATION AND JUSTIFICATION:

Approve the Administrative Match Agreement Between the County of Mariposa and Area 12 Agency on Aging for In-Kind Legal Services in the Amount of \$35,506 for Fiscal Year 2018/2019; and Authorize the Board of Supervisors Chair to Sign the Agreement. In-kind legal services provided by the County of Mariposa to Area 12 Agency on Aging will be reimbursed to the County from the \$35,506 paid to the Agency.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has approved an Administrative Match Agreement with Area 12 Agency on Aging for a number of years. Last year's agreement was approved on May 23, 2017.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not approve the agreement. The Area 12 Agency on Aging may lose funding and/or experience higher legal expenses resulting in a reduction in the benefit they provide to older Mariposans.

FINANCIAL IMPACT:

\$35,506 is included in the Fiscal Year 2018/19 Requested Budget in the Interfund Transfers budget.

ADMINISTRATIVE MATCH AGREEMENT

between the

COUNTY OF MARIPOSA

and

AREA 12 AGENCY ON AGING

THIS AGREEMENT, made and entered into this 1st day of July, 2018, by and between the **AREA 12 AGENCY ON AGING** in its capacity relating to the joint exercise of powers common to the agencies pursuant to the provisions of Article I (commencing with Section 6500), Chapter 5, Division 7, Title I of the Government Code of the State of California, hereinafter referred to as **AGENCY**, and **MARIPOSA COUNTY**, hereinafter referred to as **COUNTY**:

WITNESSETH

WHEREAS, **AGENCY** is required to provide an administrative match to funds provided for such purposes by the Older Americans Act and the Older Californians Act.

WHEREAS, the Joint Exercise of Powers Agreement creating the **AGENCY** and the Older Americans Act and the Older Californians Act allow such match to be provided through cash and/or in-kind services.

WHEREAS, pursuant to the Joint Powers Agreement, **COUNTY** is able and desires to provide its proportionate share of the administrative match as cash to the **AGENCY**;

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. GENERAL PROVISIONS

- 1.1 **COUNTY** agrees to provide on demand no later than September 30, 2018, or as agreed by the Area 12 Agency on Aging Governing Board the cash described in EXHIBIT A at the request and direction of the **AGENCY**.

2. TERMS OF THE AGREEMENT

- 2.1 This Agreement shall be effective from July 1, 2018 through June 30, 2019.
