
A RESOLUTION EXTENDING THE AGREEMENT



AGREEMENT

MARIPOSA COUNTY SMALL CLAIMS LEGAL ADVISOR PROGRAM  
(SB 180)

WHEREAS, the Board of Supervisors of Mariposa County is required by Code of Civil Procedure Section 117.18, effective January 1, 1982, to provide small claims court litigants and potential litigants with individual advisory assistance; and

WHEREAS, the undersigned members of the Mariposa County Bar Association have offered to provide, as individuals, the services specified in C.C.P. §117.18 (SB 180, 1981 Stats. Ch. 958) in the manner specified by the Judicial Council;

NOW, THEREFORE, it is hereby agreed that the following named attorneys shall provide the advisory services required by law for small claims litigants and potential litigants according to the terms and conditions described herein:

TERMS AND CONDITIONS

1. REFERRAL LIST: The Justice Court Clerk shall be provided with a list of the attorneys set forth herein, which shall be supplied to potential small claims litigants upon request. When advisory services are specifically requested, the potential litigant will be referred to the attorneys listed herein on an

1 equal rotation basis. Potential litigants shall be free to con-  
2 sult any attorney on the list at their option.

3 2. RENDERING OF SERVICES: Each listed attorney agrees  
4 to render legal advisory services as specified in C.C.P. §117.18,  
5 in the manner specified by the Judicial Council, to small claims  
6 litigants and potential litigants. No listed attorney shall be  
7 required to appear in court nor to prepare or assist in the prepa-  
8 ration of documents not to be used in small claims litigation. No  
9 listed attorney shall advise both the plaintiffs and defendants in  
10 any one small claims action.

11 In the event a listed attorney is unable to render advi-  
12 sory service at a particular time to a particular small claims  
13 litigant when contacted thereby, said attorney shall be responsi-  
14 ble to provide a referral to another listed attorney.

15 3. DISTRIBUTION OF FEES: Mariposa County agrees to  
16 collect the fees required by C.C.P. §117.14 and to distribute  
17 FOUR DOLLARS (\$4.00) of each regular six dollar (\$6.00) filing fee  
18 collected, and TEN DOLLARS (\$10.00) of each twelve dollar (\$12.00)  
19 filing fee collected, in equal portions to each of the listed  
20 attorneys at the end of the contract period specified herein.

21 4. FIVE MONTH PROGRAM: This Agreement shall be effect-  
22 ive for a five month period commencing February 1, 1982, and ter-  
23 minating June 30, 1982. It is the intent of the parties that this  
24 shall be a trial program, subject to renewal by mutual consent of  
25 all parties at the end of said trial period.
