gathering Ordinance for this occassion.





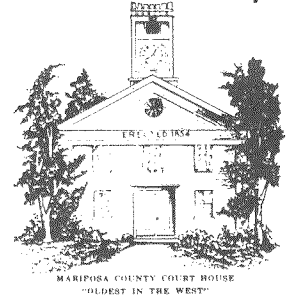
