

MARIPOSA COUNTY RESOLUTION NO. 83-210

A RESOLUTION EXPRESSING APPRECIATION TO THE COMBINED
EFFORTS OF THE COUNTY-WIDE LIBRARY COMMITTEE AND THE
FRIENDS OF THE LIBRARY

WHEREAS, the County-Wide Library Committee and the friends of the Library, in a combined effort, conceived the idea of a Library Fund Drive in August of 1982 in an attempt to replace the books being recalled by Merced County; and,

WHEREAS, under the direction of the General Chairpersons, Pearl and Trent Williams, and the operating Chairperson, Ken Meriam, a network of individuals was created to work towards one common goal--to have available quality literature for the residents of Mariposa County; and,

WHEREAS, this network of individuals donated countless hours in planning the festivities for the Library Fund Week which was held on May 7-13, 1983, and was an extremely successful event generating a significant amount of donations toward the Library Fund; and,

WHEREAS, the State Library was so impressed by the ardent effort of Mariposa County and their success in raising funds to replace books that a \$15,000 LSCA Grant was offered which was matched by a portion of the funds collected in the drive, increasing the overall fund to \$37,000.
