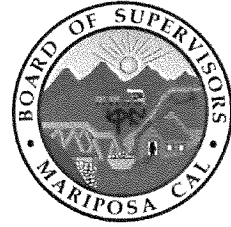

### **RECOMMENDATION AND JUSTIFICATION:**

Reappoint David Atkins and George Heiss to the Assessment Appeals Board (AAB) for a three year term beginning on September 3, 2018, and expiring at 11:59 PM on September 5, 2021.

Under California Revenue and Taxation Code (R&T) Section 1623(a), Assessment Appeals Board member terms begin on the first Monday of September (which, in 2018, is September 3rd,) are three years long, and are staggered.

Both appointees are current AAB members whose terms expire on September 2, 2018.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board routinely takes action to appoint community members to County committees, commissions, and boards.

### **ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

If the Board of Supervisors elects not to reappoint the positions, it will leave the County of Mariposa without an Assessment Appeals Board to hear citizen appeals from tax assessments.

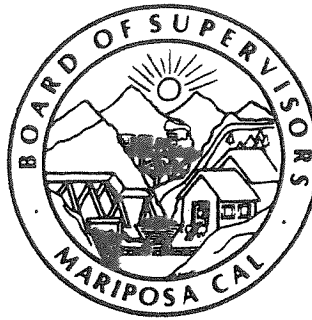

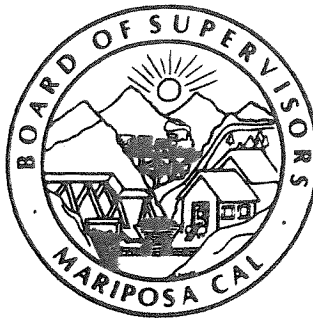
