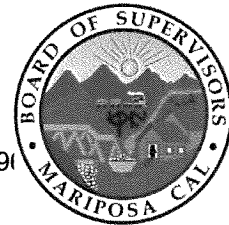

## RESOLUTION - ACTION REQUESTED 2018-443

RE: First Amendment-Agreement with Alliance for Community Transformations to Provide Housing Navigation

### RECOMMENDATION AND JUSTIFICATION:

Approve First Amendment to Agreement with Alliance for Community Transformations to provide housing navigation assistance for homeless individuals in Mariposa in an amount not to exceed \$75,000; and authorize the Board of Supervisors Chair to sign the Amendment.

The purpose of this amendment is to modify existing payment terms in Exhibit B of the agreement, creating greater flexibility and efficiency in compensating Alliance for providing valuable services to our clients. Expenses will now be invoiced monthly at the actual amount incurred each month Instead of being restricted to a fixed amount \$6,250 every month. Alliance must provide backup supporting each month's charges. The total not to exceed amount remains the same at \$75,000.

The goal of the Agreement is to help move homeless individuals into housing. Alliance agrees to provide housing navigation services to homeless individuals to assist them in the transition from homelessness to housing. Alliance will conduct intakes and provide intensive case planning and case management support to homeless individuals through the Heritage House Wellness Center and Mariposa Open Arms. Alliance will provide support and linkages to other community services, when needed, and participate in regular multi-agency team meetings to coordinate housing supports for homeless individuals.

### BACKGROUND AND HISTORY OF BOARD ACTIONS:

Mariposa County Human Services has an existing agreement with Alliance to provide housing navigation assistance for homeless individuals, approved by the Board of Supervisors on March 27, 2018 through Resolution No. 2018-129.

### ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this Amendment is not approved, the ability for the County of Mariposa to assist homeless population is negatively impacted.
