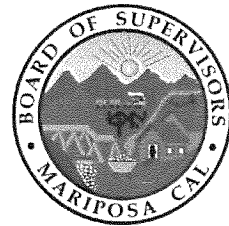

### RECOMMENDATION AND JUSTIFICATION:

Accept the Resignations of Renea Kennec, District 1 Commissioner, and Vince Kehoe, District IV Commissioner, from the Planning Commission Effective September 5, 2018. Ms. Kennec was appointed as the District I Planning Commissioner on April 14, 2015. Ms. Kennec is no longer able to serve on the Commission and submitted a resignation letter. The term for this position coincides with the District I Supervisor, Rosemarie Smallcombe.

Mr. Kehoe was appointed as the District IV Planning Commissioner on April 5, 2016. Mr. Kehoe is no longer able to serve on the Commission and submitted a resignation letter. The term for this position coincides with the District IV Supervisor, Kevin Cann.

Advertising for this vacancy was done on September 5, 2018, pursuant to the California Government Code Title 5 Division 2 Part 1 Chapter 11 54974a.

"Whenever an unscheduled vacancy occurs in any board, commission, or committee for which the legislative body has the appointing power, whether due to resignation, death, termination, or other causes, a special vacancy notice shall be posted in the office of the clerk of the local agency, the library designated pursuant to Section 54973, and in other places as directed by the legislative body, not earlier than 20 days before or not later than 20 days after the vacancy occurs."

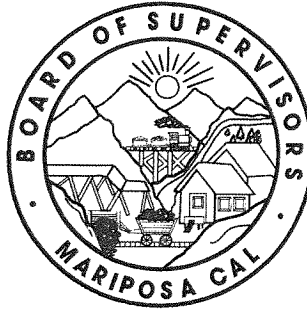

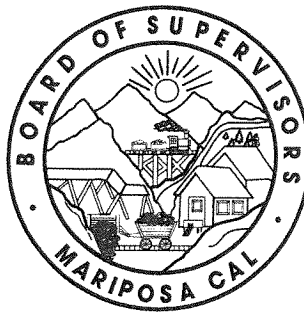
