RE: Approve the Silva Road Agreement *is Budget Action*

### RECOMMENDATION AND JUSTIFICATION:

Approve the Program Supplement Agreement with the State of California Department of Transportation for the Silva Road Project; and Authorize the Public Works Director to Sign the Agreement.

Staff has prepared the necessary State documents for the authorization of Road Rehabilitation at Post Mile 10.00 to 11.092 for Project Number RPL-5940(133) Silva Road. The California Transportation Commission (CTC) approved the allocation at their June 28, 2018 meeting. A resolution is required to authorize the Director, Public Works & Transportation to execute the Program Supplement Agreement.

### BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has approved similar Program Supplement Agreements in the past.
