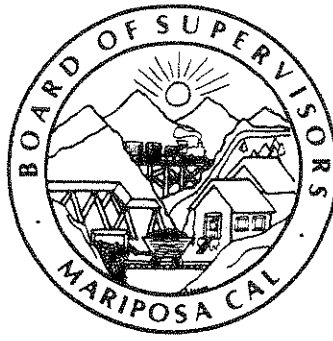

Thank you for your consideration in this matter.

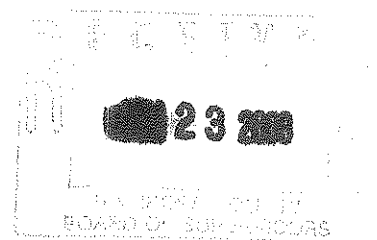
