Recommendation

It is respectfully requested that your Board: (1) approve an amendment continuing a Behavioral Health contract for Psychiatric Inpatient Services with Merced County Department of Mental Health; and (2) authorize your Chairman to sign the contract.

Background/Current Situation

This County does not operate inpatient, residential facilities and therefore contracts for such placement. Multiple contracts are necessary as beds are in short supply throughout California. If we were to limit the number of contracts, there would almost certainly be a time that someone was in danger to themselves or others, and no bed space would be available.

This contract began on July 1, 2008 and continues until June 30, 2010. The current contract was approved by your Board on May 27, 2008 by Resolution Number 08-200. The amendment includes several rate changes requested by the contractor.

Financial

The total annual contract amount shall not exceed \$2,500.00. This contract will continue to be paid within the Mental Health budget unit 0402.

There is no impact to general fund dollars.
