**Recommendation**

It is respectfully recommended that your Board authorize: (1) a continuing contract for FY 2009-2010 between the County of Mariposa and Value Options (VO) for administration of Mental Health counseling for foster children placed out of county; and (2) authorize your Chairman to sign the contract.

**Background/Current Situation**

Mariposa County has contracted with Value Options (VO) since March 2004 for mental health medical specialty services for full scope Medi-Cal beneficiaries under the age of 18 placed outside of Mariposa County. The current contract was reviewed and approved by your Board on May 27, 2008 by Resolution No. 08-199.

**Financial**

The cost of \$44.93 per eligible beneficiary is included in the current FY budget. The cost of the individual service units are reimbursed through the Medi-Cal Program.

No County general funds are required.
