

RE: Request to submit application for continued funding for the Friday Night Live Mentoring Program.

Recommendation

It is respectfully recommended that your Board: (1) authorize the department to submit application for continued funding for FY 2009-2010 between the Mariposa County Friday Night Live Partnership and The California Friday Night Live Partnership for compliance with the "No Child Left Behind Act", Title IV-21st Century Schools and all applicable regulations and federal guidelines; and (2) authorize the Human Services Director to sign the application.

Background / Current Situation

Mariposa County has, for seven years, contracted with Tulare County Office of Education and the California Friday Night Live Partnership for implementation of the Friday Night Live Mentoring (FNLN) Program. This program recruits, screens and trains high school mentors who are then matched with middle school protégés. Through sixteen supervised sessions, the mentors help the protégés develop character building skills and make healthy decisions about alcohol, tobacco and other drugs. The program helps middle school students transition to high school.

This program is part of the prevention services contract the department has with Mariposa Safe Families. The contract for fiscal year 2009/2010 will be brought to your board after receipt of grant award from the California Friday Night Live Partnership.

Financial

This contract brings in \$33,500 to the Alcohol and Drug prevention budget. This money has been budgeted for fiscal year 2009/2010. There is no local match requirement.
