**RECOMMENDED ACTION AND JUSTIFICATION:**

Adopt a Resolution and Approve the Authorization of Discharge of Accountability of the Tax Collector for the attached list of accounts which are 30 years plus old and are deemed uncollectible and Designate the County Auditor to Exercise the Authority of the Board. After 30 years liens are disallowed and so any further collection efforts would be impractical. This does not release from obligation any person to pay the amounts that are due and owing or preclude the Tax Collector from accepting payments. It only releases the Tax Collector from the obligation to actively seek payment.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

Revenue & Taxation Code 2611.1 allows for the Board of Supervisors to Discharge the Tax Collector of Accountability to collect unsecured taxes that are deemed uncollectible.

**ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

The alternative is that these accounts would stay on the active unsecured records and the Tax Collector would continue to attempt collection with no legal remedies.

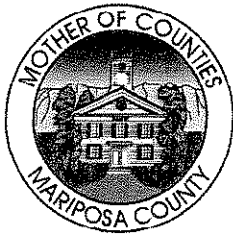

2611.1. Any county department, officer, or employee char. d by law with the collection of any county tax assessment, penalty or cost, license fees or money owing the county for any reason, that is due and payable, may file a verified application with the board for a discharge from accountability for the collection of the tax assessment, penalty or cost, license fees or money owing the county for any reason if the amount is so small as not to justify the cost of collection or if collection enforcement is impractical. The board of supervisors may adopt, with the approval of a majority of its entire membership, a resolution that authorizes and designates the county auditor as the officer to exercise the authority of the board under this section. No discharge from accountability obtained pursuant to this section shall be construed to release any person other than the person who obtained that discharge from an obligation to pay amounts that are due and owing.
