RE: Authorization to Continue a Contract with Kings View Corporation for Use of their Management Information System

**Recommendation**

It is respectfully requested that your Board: (1) authorize a contract with Kings View Corporation for continued use of their Management Information System; and (2) authorize your Chairman to sign the contract.

**Background/Current Situation**

The Management Information System is necessary to provide statistics for continued funding and to bill Medi-Cal, Medicare and private insurances for client services. The statistics gathered provide the state with demographic information such as age, gender and income level of persons using our Mental Health and Alcohol and Drug system. These statistics are also used in the Managed Care allocation methodology for determining the level of funding needed by our county. The system also generates the necessary reports for completing Federal and State cost reports and local management reports for budgeting employees time to program.

Under prior agreements, the County owns the computer equipment that is on site. The new Anasazi system, implemented in 2007, provides Behavioral Health with many automated features that were not possible in the past.

**Financial**

This continuation contract includes the following costs; Anasazi unlimited user license \$114,200, a one time fee, Doctor's homepage user prescriber license \$13,000, Visual DataFlex users fee \$1,000 and the annual recurring costs of \$25,570. These costs are incorporated in the current budget.

There is no impact on the general fund.
