Of Schools for the Friday Night Live Mentoring Program.

**Recommendation**

It is respectfully recommended that your Board: (1) authorize the department to accept a continuing grant agreement for FY 2009-2010 between the Mariposa County Friday Night Live Partnership and the Tulare Superintendent of Schools for The Friday Night Live Mentoring Program for compliance with the "No Child Left Behind Act", Title IV-21<sup>st</sup> Century Schools and all applicable regulations and federal guidelines; and (2) authorize the Human Services Director to sign the agreement.

**Background / Current Situation**

Mariposa County has, for seven years, contracted with Tulare County Office of Education and the California Friday Night Live Partnership for implementation of the Friday Night Live Mentoring (FNLM) Program. This program allows Mariposa County Behavioral Health and Recovery Services to contract with Mariposa Safe Families for Prevention activities with Mariposa County youth. This program helps them with character building skills and teaches them to make healthy decisions about alcohol, tobacco and other drugs. The program helps middle school students transition to high school.

**Financial**

This contract brings in \$33,500 to the Alcohol and Drug prevention budget. This money has been budgeted for fiscal year 2009/2010. There is no local match requirement.
