RECOMMENDED ACTION AND JUSTIFICATION:

Resolution authorizing the Chairman of the Board of Supervisors to sign ARRA Stimulus Project Agreement No. 09-0555 with the California Department of Food and Agriculture (CDFA) for three projects -- Project I: Mapping and Inventory of A & B Rated Weed Populations, Project II: Treatment of A & B Rated Weed Populations, and Project III: Yellow Starthistle Leading Edge Program and approve Budget Action Accepting Unanticipated Revenues of \$13,710 for FY 2009/10

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The ARRA Stimulus Project Agreement No. 09-0555 with CDFA is funded under the ARRA Stimulus Project legislation and provides funding for 3 noxious weed control projects. The projects are: Project I: Mapping and Inventory of A & B Rated Weed Populations, Project II: Treatment of A & B Rated Weed Populations, and Project III: Yellow Starthistle Leading Edge Program. This is a new contract which is funded in the amount of \$ 55,846 for the term of 1/01/10 - 12/31/11.

The budget action accepts unanticipated revenue of \$13,710 to implement the three ARRA Stimulus Projects for FY 2009/10.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Approving this contract and budget action will provide funding and reimbursement for the three ARRA stimulus projects. If the contract and budget action are not approved, the projects will not be implemented.
