RECOMMENDED ACTION AND JUSTIFICATION:

Authorize the Acceptance of a Portion of Cuneo Road and Stout Lane into the County-Maintained Road System in Exchange for the Previous Closure and Abandonment of a Portion of Hayward Road.

Public Works is requesting authorization to include a portion of Cuneo Road and Stout Lane into the County-maintained road system to complete the exchange of road mileage for the previous closure and abandonment of a portion of Hayward Road. The net result will not be an increase in the maintained mileage as 2.11 miles were removed in February 2001, approximately 1.07 miles were replaced by Board action on September 16, 2003 and additional 1.0 miles is being requested for inclusion in order to keep the amount of maintained road mileage essentially the same.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board approved the closure and abandonment of a portion of Hayward Road in February 2001. At that time there was discussion of replacing lost mileage with other non-County maintained roads.

In July 2003, the Board amended the County Road Policy enabling the acceptance of a road into the County-maintained system based upon the County Engineer's recommendation that a road that is currently in the County-maintained road system is no longer needed to be maintained by the County and a road of similar proportions which is not in the County-maintained system serves a high public purpose.

On September 16, 2003, the Board instructed staff to return with the request to add a portion of Cuneo Road and a portion of Stout Lane to the maintained-mileage system in order to bring back the total to the original amount.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Negative action will result in the proposed road not receiving a minimal amount of maintenance and a reduction in the maintained mileage inventory.

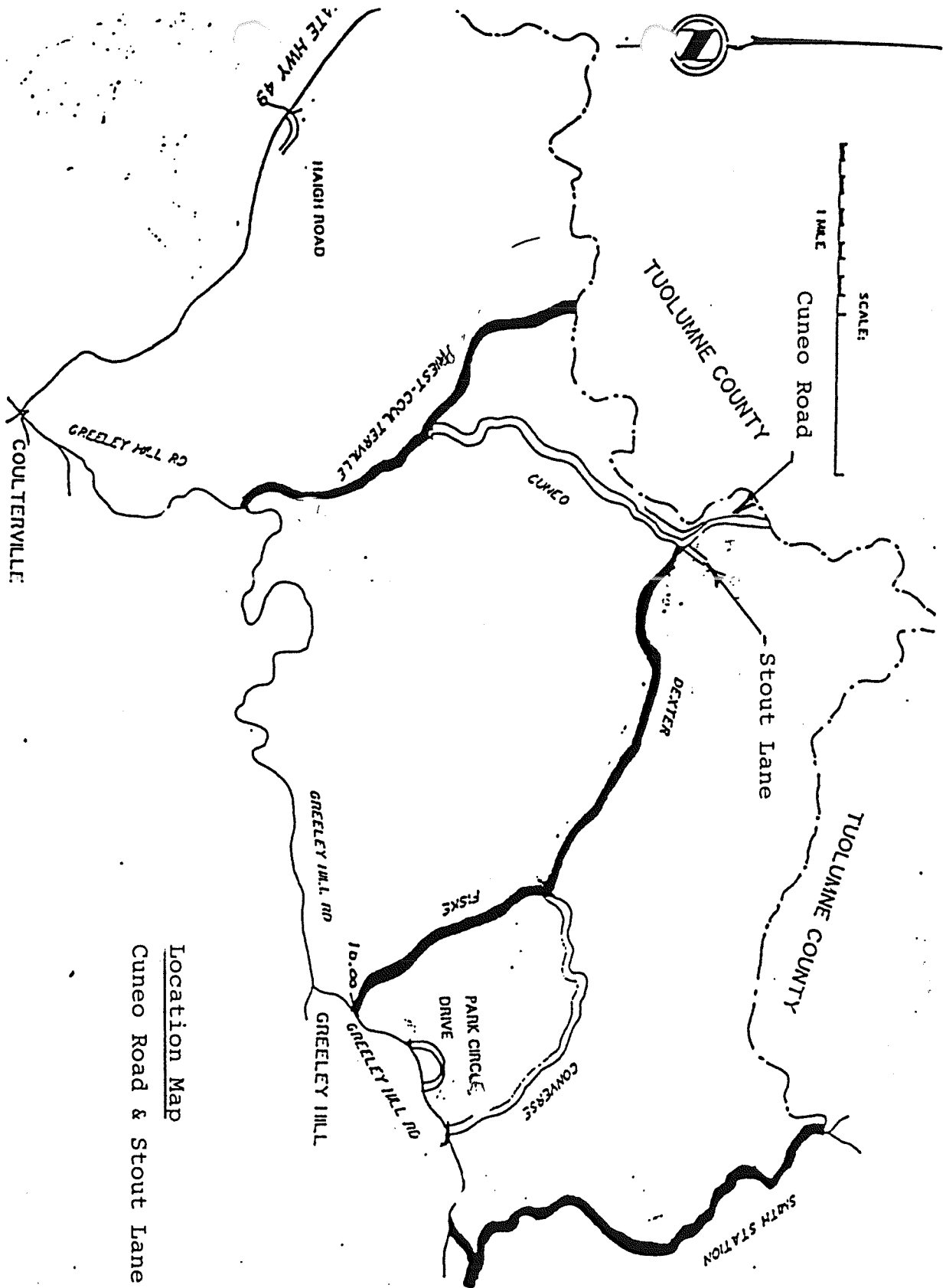
