

MARIPOSA COUNTY RESOLUTION NUMBER 03- 373

A RESOLUTION RECOGNIZING DALE W. WAGERMAN
UPON HIS RETIREMENT FROM
STRATEGIC LOCAL GOVERNMENT SERVICES LLC

WHEREAS, DALE W. WAGERMAN began his work for Mariposa County in 1996, providing Legislative/Regulatory Services through Wagerman Associates, Inc.; and

WHEREAS, DALE was invaluable to Mariposa County through his assistance in our sponsored legislation AB 2400 (House) which sought to address the existing inequity for the unincorporated counties of Mariposa, Alpine and Trinity for whom were not receiving their fair share of the Gas Tax or the Vehicle License Fee. While AB 2400 failed in the Assembly Committee on Appropriations, Dale who would not give up, found AB 473 (Oller), which was inactive in the Senate Committee on Local Government. Dale was again instrumental by amending AB 473 and seeking approval for placing the contents of our legislation in this new bill. With Dale's many years of experience and assistance, we were able to gain passage of AB 473 through the legislature. Governor Pete Wilson signed AB 473 (Oller) into law in October 1997 placing a new definition "counties with no incorporated cities" into the statute; and

WHEREAS, DALE was instrumental in working with the County in successfully gaining the approval for an allocation of approximately \$200,000 for the construction of the second phase of the Mariposa County Creek Parkway; and

WHEREAS, DALE was again instrumental while working for the County by successfully gaining the approval for an appropriation for \$50,000 for the retention of the California State Mining and Mineral Museum in Mariposa County; and

WHEREAS, DALE played a highly important roll in the crafting of legislation as a result of the pending Stayner Trial for the reimbursement of costs to rural counties for high profile capital cases; and

WHEREAS, DALE has helped to protect local government funding by securing the reimbursement from the Williamson Act, the assault on the Transient Occupancy Tax (TOT), and successfully retaining library funding for Mariposa County just to name a few; and

WHEREAS, DALE also played a significant part in obtaining \$500,000 from the Rural Counties Crime Prevention Act for the Mariposa County Sheriff's Department for several years; and


WHEREAS, DALE has sponsored, supported, amended, and opposed legislation and regulations to the benefit of Mariposa County; and

WHEREAS, DALE has assisted county departments on the effects of legislation and on means to maximize state and federal funding for county programs; and


